Textual Information(1)	The SEBI has, vide Notification dated 08.09.2025 amended, Regulation 39 of the SEBI (LODR) Regulations, 2015 by inserting a new regulation 39(2A) which reads as under: The listed entity shall issue securities pursuant to any Scheme of Arrangement or any sub-division, split or consolidation of securities only in the dematerialised form: Provided that the listed entity shall open a separate demat account for such securities of investors not having demat account. The Members of the Company at their meeting held on 22.08.2025 approved the split / sub-division of 1 (One) Equity Share having face value of Rs. 10/- (Rupees Ten Only) each, into 10 (Ten) Equity Shares having face value of Rs. 1/- (Rupee One Only) each, with effect from the record date i.e.18.09.2025. To comply with the above mentioned newly inserted regulation, the Company opened a separate demat account for issuance / transfer of shares on sub-division / split of shares for shareholders who were not having demat account and transferred shares in physical form to that account, which includes 400 shares (i.e.100 shares belonging to Ramila R Kilachand and 300 shares belonging to Amrish R Kilachand) belonging to promoter and promoter group and that account is classified under Public Category. Therefore, actual shareholding of promoter and promoter group is 71097244 as against 71096844 as shown in the shareholding pattern.
