# HC to Centre: What was the need to introduce new IT Rules

**HUMBAI**  
The Bombay High Court on Friday asked the Union government what was the need to introduce the recently notified Information Technology Rules, 2021 without superseding the existing IT Rules that came into effect in 2009. A bench of Chief Justice Dipankar Datta and Justice GS Kulkarni reserved its order on two petitions seeking an interim stay on the implementation of the new Rules. The pleas, filed by digital legal news portal Leaflet and journalist Nikhil Wagle, raised objections to several provisions in the new Rules and said these were likely to



have a "chilling effect" on a citizen's right to free speech as guaranteed by the Constitution. The petitioners also claimed the Rules went beyond the scope of the parent IT Act as well as the reasonable restrictions imposed on speech and expression by Article 19 (2) of the Constitu-

tion. On Friday, the bench said orally that it was inclined to grant limited relief to both petitioners over serial number nine of the new Rules that related to adherence to a code of ethics. Earlier during the day's hearing, Additional Solicitor General Anil Singh, appearing for the Centre, defended the prescription of such ethics saying that even the Press Council of India (PCI) prescribed a code of ethics to be followed by journalists. The bench, however, pointed out that PCI guidelines were advisory norms on behaviour and did not carry any drastic punishment for their breach.

# Outrage in K'taka as hotel uses saint's image for Biryani publicity

Hindu organizations are outraged after a famous hotel here specialising in biryani released posters containing the image of a Hindu saint appreciating the meat and rice dish. The hotel chain across the city had to be shut and police deployed from Thursday evening to prevent any violence. 'Niyaz Hotel', which owns many restaurants in the city, had released the posters on social media where a Hindu saint was seen asking his devotees to give him biryani instead of 'Balidaan' (sacrifice). The poster also contained the caption "Guruji after tasting Niyaz". The caption to the post on social media said, "Our Biryani to all other Biryani-Aham Brahmasmi (I am divine)". The post went viral and Hindu organizations were up in arms over the advertisement. They claimed that the hotel management has insulted Hindu saints and Hindu traditions. Vishwa Hindu Parishad (VHP) and Bajrang Dal leaders met the Police Commissioner and submitted a memorandum against the hotel management. They have urged



strong action against the hotel management. Local BJP leaders gave a call to Hindus to come forward and register their protest. Sensing trouble, the police department closed down all hotels of the group and deployed policemen at the hotel premises. Niyaz hotel management later took down the controversial poster and apologised for hurting religious sentiments of the Hindus.

# Those who own one flat shouldn't be allowed 4-5 cars: HC

Expressing anguish over the lack of any uniform policy in Maharashtra over designated parking spaces for vehicles, the Bombay High Court has said that authorities must not allow citizens to own multiple personal vehicles if they didn't have adequate parking space. A bench of Chief Justice Dipankar Datta and Justice G S Kulk-

rni said on Thursday that authorities "should not allow families owning only one flat to have four or five cars if they do not have sufficient parking space" available in their respective housing societies. The bench was hearing a public interest litigation (PIL) filed by a Navi Mumbai resident and activist Sandeep Thakur, challenging a government notification that amended the Unified Development Control and Promotion Regulations Rules,

permitting developers to reduce car parking space. Thakur said in his plea that developers do not provide sufficient parking spaces in new highrises, thereby forcing residents to park outside the premises of the housing society. Reduction in the purchase of new cars is needed. You can't permit one family to have four to five vehicles just because they can afford it. You should cross-check if they have parking spaces or not," the high court said.

**TN govt reduces petrol price by Rs 3 per litre**

CHENNAI

In a major relief to the working-class in the State, the Tamil Nadu government on Friday announced to reduce the price of petrol by Rs 3 per litre.

Tamil Nadu Finance Minister Palaniivel Thiagarajan while presenting the budget on Friday said that the petrol prices have been slashed by Rs 3 and because of this, the state government will face a deficit of Rs 1,160 crores in a year.

"Tamil Nadu has 2.6 core of people using two-wheelers. Rs 3 is reduced in petrol by the Tamil Nadu government. Because of this government will face a Rs 1,160 crores deficit," said the state minister.

According to the revised budget estimates 2021-2022, the state government has decided to reduce the effective rate of tax on petrol by Rs 3 per litre and thereby provide major relief to the toiling working-class people in the State.

**HC TO CENTRE: What was the need to introduce new IT Rules**

**UNLESS THERE** is liberty of thought, one can't express oneself: Bombay HC

The Bombay High Court on Friday asked the Union government what was the need to introduce the recently notified Information Technology Rules, 2021 without superseding the existing IT Rules that came into effect in 2009.

A bench of Chief Justice Dipankar Datta and Justice GS Kulkarni reserved its order on two petitions seeking an interim stay on the implementation of the new Rules.

The pleas, filed by digital legal news portal Leaflet and journalist Nikhil Wagle, raised objections to several provisions in the new Rules and said these were likely to



have a "chilling effect" on a citizen's right to free speech as guaranteed by the Constitution.

The petitioners also claimed the Rules went beyond the scope of the parent IT Act as well as the reasonable restrictions imposed on speech and expression by Article 19 (2) of the Constitu-

tion. On Friday, the bench said orally that it was inclined to grant limited relief to both petitioners over serial number nine of the new Rules that related to adherence to a code of ethics.

Earlier during the day's hearing, Additional Solicitor General Anil Singh, appearing for the Centre, defended the prescription of such ethics saying that even the Press Council of India (PCI) prescribed a code of ethics to be followed by journalists.

The bench, however, pointed out that PCI guidelines were advisory norms on behaviour and did not carry any drastic punishment for their breach.

**Those who own one flat shouldn't be allowed 4-5 cars: HC**

Expressing anguish over the lack of any uniform policy in Maharashtra over designated parking spaces for vehicles, the Bombay High Court has said that authorities must not allow citizens to own multiple personal vehicles if they didn't have adequate parking space.

A bench of Chief Justice Dipankar Datta and Justice G S Kulk-

rni said on Thursday that authorities "should not allow families owning only one flat to have four or five cars if they do not have sufficient parking space" available in their respective housing societies.

The bench was hearing a public interest litigation (PIL) filed by a Navi Mumbai resident and activist Sandeep Thakur, challenging a government notification that amended the Unified Development Control and Promotion Regulations Rules,

permitting developers to reduce car parking space. Thakur said in his plea that developers do not provide sufficient parking spaces in new highrises, thereby forcing residents to park outside the premises of the housing society. "Reduction in the purchase of new cars is needed. You can't permit one family to have four to five vehicles just because they can afford it. You should cross-check if they have parking spaces or not," the high court said.

**Voter ID to be linked with Aadhaar, but only in 2023**

In an attempt to prevent forged voting, the Election Commission has decided to link the electoral rolls and the Voter ID with the 12 digit Aadhaar number early 2023 after the Assembly elections are completed in five states, including Uttar Pradesh and Gujarat.

It has written to the government to amend the laws for facilitating this linkage. The electoral rolls will not be seeded in the Aadhaar system, but the verification will be done through OTP system to ensure the electoral rolls are not intercepted.

The Election Commission had already linked more than 30 voter IDs with Aadhaar in 2015 before a stay granted by the Supreme Court.

am divine") The post went viral and Hindu organizations were up in arms over the advertisement. They claimed that the hotel management has insulted Hindu saints and Hindu traditions.

Vishwa Hindu Parishad (VHP) and Bajrang Dal leaders met the Police Commissioner and submitted a memorandum against the hotel management. They have urged

strong action against the hotel management. Local BJP leaders gave a call to Hindus to come forward and register their protest. Sensing trouble, the police department closed down all hotels of the group and deployed policemen at the hotel premises. Niyaz hotel management later took down the controversial poster and apologised for hurting religious sentiments of the Hindus.
